 - users of social media platforms \rightarrow claim a **micro tax** on their data





+User generate bots +Sending claims

- VPN + IBM's AI-Watson Natural Language Classifier Service (自 然語言處理) to train social media bots
- Why bots ?
 - **low-cost** (no need to pay the salary)
 - **powerful**, **effective** (no need to eat and sleep)
 - able to mine BitSoils
- **Two** types of bots:
 - prospector bots
 - **detect** the keyword and **invite** users join the campaign
 - tax-collector bots
 - set of predefined tax claims
 - send regular intervals to leaders and influencers
 - the CEO's of the top 10 biggest tech giants
 - the Prime Minister



 - ▶ 440.145774 x 0.0427 = 18.7942245
 - raise 8,5 billion on tax money at an annual base
 of 200 billion tweets per year.



This is the total amount of bitsoils produced by all the users and their bots during the bitsoil popup hack & tax campaign. Join us and let's make the data economy benefits everyone!






BlockChain Introduction




